# SP Blue Eyed Ghost Stallion Service Contract Shipped Fresh Semen 2023-2024 Breeding Season For The Stallion "SP Blue Eyed Ghost"





I \_\_\_\_\_ ("Mare Owner") hereby confirm the application for a service booking to "SP BLUE EYED GHOST" upon the following terms and conditions.

This contract is made by and between Petticoat Lane Performance Horses ("Stud Farm") and the Mare Owner bering the person responsible for the Mare - whether owned or leased.

- 1. **FEES:** The Mare Owner agrees to pay the Stud Farm the following fees:
- The service fee is \$2000 including a booking fee of \$500.
- An early bird special of \$1800 is available for facebook followers providing the contract is signed and the booking fee is paid by September 1st 2023 and you are one of the first 15 contracts signed and received.
- The booking fee of \$500 is due at the signing of this contract. This will ensure a place for your mare in this stallion's book. This fee is deductible from the Service Fee of \$2000 (\$1800 if an "early bird").
- The remainder of the service fee \$1500 (\$1300 if an "early bird") is payable BEFORE the first shipment of semen is sent. No semen will be provided until such time as the service fee is paid in full.
- The collection fee for the first collection is included in the service fee. The fee for subsequent collections will be \$200 to collect, evaluate, package semen and ship via courier.
- The Stud requires that the shipping container is returned within 48 hours at the cost of the
  mare owner. Failure to attend to this will result in \$50 being billed to the Mare Owner to cover
  the cost of a replacement container.
- All invoices are payable on receipt of an invoice, issued by the Stud farm. Petticoat Lane
  Performance Horses prefers direct credit into our bank account (details below). Please ensure
  your name and the name of the mare appears in particulars.

#### 2. RESERVATIONS FOR SEMEN:

- The receipt of the Service Fee confirms the Mare's reservation to breed to SP BLUE EYED GHOST in the current breeding season which extends from September 1st 2023 until 1st March 2024.
- Orders for semen must be placed **48 hours** before semen is required.
- The Mare Owner acknowledges that the stallion may be competing away from the Stud Farm during the breeding season. It is the Mare Owner's responsibility to check semen availability in advance.
- The semen will be sent to the Mare Owner's Veterinarian at the address provided in this contract.

### 3. RETURN SERVICE CONDITIONS/LIVE FOAL GUARANTEE:

- The mare will be limited to being bred on four cycles in any one breeding season.
- If the mare fails to get in foal she may return the following season, but will be liable for another booking fee (which includes the first collection fee) and any associated insemination costs. It is

- accepted that the Stud Farm may require a negatives uterine culture (swab) certificate prior to the Mare's return service.
- If the mare tests positive for pregnancy but becomes barren during gestation, she will be eligible for a return service, but will be liable for another booking fee (which includes the first collection fee) and any insemination costs. A certificate of barrenness must be sent to the Stud Farm as soon as practical after loss of the foal.
- If the mare produces a live foal that is unable to stand or suckle within 24 hours and it
  subsequently dies or is destroyed the Mare is eligible for a return service but will be liable for
  another booking fee (which includes the first collection fee), and any insemination costs. A
  veterinary certificate must be provided to the Stud Farm as soon as is practical after the foal's
  death. Failure to provide a certificate in a timely manner (within 14 days) will make return of
  service policy null and void.
- If the mare becomes unable not be breed for any reason, the Mare Owner may swap the return service to another mare after gaining the permission of the Stud Farm, and completing another contract with the new mares details.
- All rights of return to the Stallion do not include Booking, Collection, Transportation fees nor other associated costs.
- The live foal guarantee does not apply:
  - If the mare is sold, exported, or dies unless permission is granted from the Stud Farm.
  - If the mare is not foaled under supervision.
- The Mare Owner shall have 2 years in which to exercise the free return service. If the free return service is not utilised within this time period the mare owner shall forfeit all rights unless a new agreement is made with Petticoat Lane Performance Horses in writing.

#### 4. REFUND OF FEES:

• The mare owner will be entitled to a refund of the Service Fee if the Stallion dies or becomes unfit for breeding prior to serving the mare in the present season. However no refund will be given if the mare has already had her first insemination. Alternatively frozen semen is available.

#### 5. WARRANTY:

• The mare owner hereby releases the Stud Farm for any responsibility or liability for lost, delayed, or damaged semen due to circumstances beyond their control. Every effort, preparation, and precaution will be taken by the Stud Farm to ensure the semen is delivered to the Mare Owner's listed Veterinarian in the same condition it leaves the Stud Farm.

#### 6. ISSUE OF THE BREEDING CERTIFICATE:

 Only one Certificate of Service will be issued for this contract. This certificate will pertain only to the Mare described in this contract. The Certificate will be issued once the mare is tested 42 day in foal and all outstanding invoices have been paid by the Mare Owner.


#### 7. OTHER CONSIDERATIONS:

• The Mare must not carry the cream dilution gene. The mare must only be black, brown, bay, chestnut, or grey. Paint horses are also ok as long as they are not dilute ie they need to be any of the above examples in combination with white. No Cremello, Palomino, Buckskin, or Smokey Black mares may be bred to Ghost. Failure to comply with this stipulation will result in legal action being taken against the Mare Owner, and penalties being applied.
